### Memorandum of Understanding

This Memorandum of Understanding (hereafter be called as the "MoU") is entered into on this Twenty Fourth February, Two Thousand Twenty-One (24.02.2021), by and

between

**Rotary International District- 2982** represented by its **DISTRICT GOVERNOR** (which expression, unless excluded by or repugnant to the subject or context shall include its successors – in – office, administrators and assigns), the party of the **First Part**.

and

**Internal Quality Assurance Cell (IQAC), Government Arts College (Autonomous), Salem-636007** represented by its **PRINCIPAL** (which expression, unless excluded by or repugnant to the subject or context shall



include its successors – in – office, administrators and assigns), the party of the **Second Part.**

- a) **WHEREAS**, the party of the First Part and the party of the Second Part believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- b) Both the Parties intend to co-operate and shed focus on their efforts to forge co-operation within the area of Teaching, Learning, Education, Training and Research for quality enhancements.
- c) This collaboration is made purely for academics, trainings and service-related co-curricular and extracurricular purposes as a quality initiative by **IQAC of Government Arts College (Autonomous), Salem-636007** **NOW THEREFORE**, in consideration of the mutual promises set forth in this MoU, the parties hereto agree as follows:

#### **Clause 1**

##### **Co-operation**

- 1.1 Both the parties are united by common interests and objectives and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the institution and related wings.
- 1.2 The cooperation between the party of the First Part and party of the Second Part will facilitate effective utilisation of the intellectual capabilities and resources of the party of the First Part in orienting, nurturing and grooming teaching faculty students and staff, who are in different stages on various competencies and skills related to quality oriented sustainable education environment and methodologies at the best possible ways.

#### **Clause 2**

##### **Scope of MOU**

- 2.1 The teachers play a crucial role in enhancing the quality of the students by way of effective and innovative teaching-learning methods and pedagogy. Both parties believe that close co-operation between the two would be of major benefits to the teaching and student community to enhance their skills and knowledge related to quality education and sustainable development.
- 2.2 This is a voluntary collaboration and there are no financial commitments on the part of both the parties.

**Clause 3**  
**Focus Area**

- 3.1 **Rotary International District- 2982**, is a registered non-governmental organisation, engaged in social services and trainings AND WHERE both “**IQAC, Government Arts College (Autonomous), Salem-636007**” and **Rotary International District- 2982** are desirous of associating with each other to expertise students, faculty and staff of **Government Arts College (Autonomous), Salem-636007** on the following academics related co-curricular and extracurricular activities by conducting Expert Lectures / Seminars/ Webinars/ Workshops/ Internship / Industrial Visits / Consultancy / Quality viz Quality Enhancement activities either offline or online as an addition to curriculum in coordination with **IQAC, Government Arts College (Autonomous), Salem-636007**.

**Clause 4**  
**Responsibility Structure**

- 4.1 **Rotary International District- 2982** and **IQAC, Government Arts College (Autonomous), Salem-636007** shall be responsible jointly for arrangements for executing academics, trainings and service-related co-curricular and extracurricular activities with fullest cooperation mutually as mentioned in the Clause 3 of this document.
- 4.2 **IQAC** will maintain the records and **IQAC** Coordinator will evaluate the effectiveness and adherence to the agreement.

**Clause 5**  
**Validity**



**Relationship between the parties**



Neither party shall have nor represented itself as having any authority under the terms of this **MoU** to make agreements of any kind in the name of or binding upon the other party to pledge such other party's credit or to extend credit on behalf of such other party.


