The Institute shall endeavor to ensure fair implementation of this policy so as to meet with the objectives of its formulation

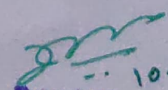
The respective heads of the departments shall be responsible for the compliance of the Institutional policy related to the handling of information resources.

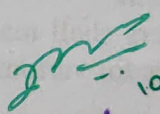
