It also provides an overarching framework for the development and implementation of all research perspectives at Government Arts College(Autonomous), Salem-7 adhering to all the terms of affiliating with Periyar University. The policy is applicable to all disciplines of the institution to develop a robust and responsible research culture with honesty and integrity.

Scope

The usage of institutional resources and utilizing funds by national and international bodies for promoting the vision and mission of the institution in research and development activities.

Objectives

- To promote the research and development activities of the institution for enhancing its quality to get good ranks in all academic accreditation agencies.
- To promote research activities among stakeholders
- To take all research activities towards consultancy services

Policy Statement

1. Providing infrastructure through the various research departments in the campus.
2. Encouraging faculty to apply for recognition as research guides both for M.Phil. and Ph.D.
3. Motivating the faculty to apply for Major and Minor research grants provided by the Government organizations such, as UGC, DBT, BIRAC, ICMR, BRNS, DST, etc. with the support of the research committee
4. Supporting the BOS of every department that promotes by incorporating a research component in the syllabi of every subject.
5. Showcasing the research carried out by the student and the faculty through its registered peer review, UGC CARE recognized journal, Xplore with separate editions for Sciences and Humanities.
6. Engaging a research consultant to advise new researchers, assist those applying for grants in the new fields, and guide them to initiate collaborative projects with the industry.
7. The college also strictly prohibits plagiarism at all levels and facilitates the monitoring and mitigation of malpractice through online tools.
8. Research proposals submitted by stakeholders either in the form of student projects or faculty projects funded by Government/ Industry /NGO etc have to be channelised by the Research Committee.

Operating Aspects

The institution shall endeavor to ensure fair implementation of this policy so as to meet with the objectives of its formulation

The respective personnel of the committee shall be responsible for the compliance of the institutional policy related to the research activities .


